1. OAR VALUES

1.1 INTERNATIONAL UNDERSTANDING

International Rowing Events & Meetings are organized to be a contact friendly among the participants, contributing for a better understanding between people and nations, regardless of race, gender, nationality, beliefs or political system. Rowers form a worldwide family based on the ideals of peace, friendship, justice, understanding and mutual help. All rowers are encouraged to nurture an international understanding through the practice of rowing.

1.2 INDIVIDUAL DEVELOPMENT

Through rowing, the individual acquires a personal experience of determination, spirit of respect, responsibility, integrity and Sense of fair play. Applying these principles in under all circumstances the rowers become independent and responsible individuals, prepared to face the reality of life.

1.3 ENVIRONMENTAL RESPONSIBILITY

Rowing is a sport that requires air and water clean. Remo community plays an important role in sustainable resource management natural and social especially those who are required for rowing.

1.4 SPORT FOR ALL

Rowing allows good condition to be maintained physics at all ages. Rowing is a competitive and recreational activity independent of age, gender or ability.

2. HIGHLIGHTS

2.1 OLYMPIC BRAZIL AWARD

Rower Uncas Tales Batista received the Prize Olympic Brazil 2018 of best athlete in the Rowing category. The delivery ceremony of the 20th edition of the award took place in Rio de Janeiro, December 18, by the Brazilian Olympic Committee (COB). Defending the Brazilian Rowing Team, Uncas won in 2018 his second gold medal in Men's Lightweight Single Skiff U23 at the U23 World Rowing Championship, held in Poznan, Poland. With the unprecedented result, Uncas became the first Brazilian rower to win a world championship twice in a row. Botafogo athlete, the rower has conquered this year by the club the first place of the Men's Single Skiff in the Brazil Boat Trophy Short In the Brazilian Championship, there were two individual gold medals in the boats





stage Short films and five collective wins in the Long boats. This was the second Brazil Award Rower's Olympic who also took the trophy of best rowing athlete in Season 2017.

2.2 PARALYMPIC AWARD

Two-time world champions Jairo Klug and Diana Barcelos received the best athletes trophy for parade at the 2018 Paralympic Prize. The event is held annually by the Committee Paralympic Championship, the ceremony was at CT Paralympic Games, in São Paulo, on 12/12, Diana Barcelos started rowing in 2016 and in just two years already achieved results expressive. Amputee of the leg, the 30-year-old athlete years trains for Flamengo (RJ) in the PR3 category. She was Double Skiff Mixed PR3 Champion at Para-Rowing Championship in 2017 and 2018. In her first world championship in 2017, Diana won the gold medal alongside Jairo at Double Skiff Mixed PR3. In 2018, the duo repeated the gold and conquered the unprecedented Brazilian double championship of the category in a rowing world. Jairo Klug has rowed for over ten years when you lost your finger movements and wrist extension of the left hand. The paulista 34-year-old trains at Pinheiros (SP), club for which was champion in Brazilian Para-Rowing in 2017 and 2018 in Two Men Without PR3 and on Double Skiff Mixed PR3. Jairo also won in 2017 in the category Single Skiff PR3. In addition to Two-time world championship, Jairo participated in several international events for the national team.

3. NATIONAL CHAMPIONSHIPS

3.1 BRAZILIAN CHAMPIONSHIP

Short Boats Flamengo (RJ) became champion in the Short Boat Brazilian 2018. The carioca team took the podium 21 times, taking home nine gold, eight silver and four bronze. In all, 144 athletes were registered, representing 20 clubs from nine states. The 21 events of the event were played in two phases. In the first phase of the championship, Brazil Short Boat Trophy, between 15 and 17/03, five tests were held without distinction Category: Single Skiff Male, Single Skiff Female, Two Without Men, Two Without Women and an extra Single Skiff Men's Trial Junior. This phase of the championship also makes part of the National Selective, mandatory stage of evaluation for rowers who intends to to participate in the Brazilian team. Flamengo got three wins: Single Women's Skiff (Milena Vianna), Two No Men (Willian Giaretton and Xavier Vela Maggi) and Two Without Female (Yanka Vieira Brito and Milena Vianna). The Botafogo of Football and Regattas (RJ) Won in the Single Skiff Men's (Uncas Tales) and Esporte Clube Pinheiro (SP) at Single Skiff Junior Male (Marco Misasi). In the second phase, Brazilian Shortboat, 17 finals were played on 18/03, with the six fastest boats in each category from the ranking defined in the first phase. Flamengo won six medals of gold, totaling nine victories between the two stages of the championship. Secondly, the Botafogo had six wins in total and Pinheiros two. Vasco da Gama also won two gold, the tiebreaker was decided by the amount of silver medals for each club: three for Pinheiros and two for Vasco. The event was organized by the Confederation Brazilian Rowing with funds from the Agnelo Law / Piva supporting the sport. In addition to the loan of boats to the registered clubs, CBR, in partnership with CEPEUSP and the Paralympic Committee Purchased buoys, wires and all the necessary material for the FISA





standards. The Brazil Trophy Winners won Athlon glasses from Mormaii, a company CBR supporter at this event.

3.2 BRAZILIAN CHAMPIONSHIP

Rowing Master

The Rio de Janeiro Rowing Club (RJ) became champion in the Brazilian Championship of Rowing Master 2018, held in Brasilia between June 15th and 17th. There were 22 medals of gold for the carioca club, which was followed by Sport Club Corinthians (SP) in second place with 19 golds and by the Guanabara Club (RJ), in Third place with 15 gold medals. More than 400 championships took part in the championship rowers from across the country, representing 27 clubs and associations. The 150 events of the event were played at Minas Brasilia streak Club, located on the shores of Lake Paranoá. The Brazilian Master Rowing Championship 2018 was organized by the Brasilia Rowing Federation (FRB) with support from CBR.

3.3 NORTHEAST NORTH ROWING CUP

The Rowing Club (PA) was established as champion of the North North Cup of Rowing 2018, that happened on July 14, in Brasilia. The club paraense won four gold medals, four silver and three bronze. The runner-up trophy went to Esporte Clube Vitória (BA) with four gold and three bronze medals. Vitoria stood out in the men's race, rising to the top of the podium in Dois Sem Senior, Two Without Sub 23, Four Without Senior and Single Skiff Junior B. The Rowing Club had balanced wins with two men's podiums (Single Skiff Senior and Double Skiff Sub 23) and two female podiums (Single Skiff Junior and Single Skiff Senior). The third place of the championship stayed with Minas Brasilia Tennis Club (DF), which won three gold and two silver. The 17 events of the event were played in the same day, morning and afternoon. They were 92 rowers from 16 clubs, representing seven states. The event was organized by CBR in partnership with the Rowing Federation of Brasilia (FRB). In all, there were 15 professionals working between arbitration, maintenance and medical assistance staff. The CBR project counted with ambulance ICU, awards material, podium structure, outreach, photo coverage, tickets and accommodations for the team who worked on the event.

3.4 BRAZILIAN CHAMPIONSHIP

LONGBOAT

Botafogo (RJ) took home the trophy of Champion in the Brazilian Longboat 2018, held between 18 and 21/10 at Lagoa Rodrigo de Freitas, in Rio de Janeiro. The club has won 12 of 25 contested events. In second place was Flamengo (RJ), with 9 wins, followed by Esporte Clube Pinheiros (SP), with 2 wins. The event started on Wednesday, October 17, with the holding of the Technical Congress. The knockout events were played in the Friday morning and the recaps in the evening. The athletes faced difficulty with the weather, because the wind caused a lot of wind. At the saturday and sunday, race days At the end, the wind subsided and calmed the lagoon. The CBR received applications from 266 athletes, 96 rowers and 169 rowers. In all, over 320 people including coaches, auxiliaries and leaders were present at the event representing 26 clubs and eight states. The Brazilian Longboat 2018 was organized by CBR with funds from the

Agnelo Piva Law. Supporting the sport. The event team told with 35 people among CBR employees, referees, spearmen and health professionals. THE championship had support from the Rowing Federation of the State of Rio de Janeiro (FRERJ), Secretariat of Sport, Leisure and Youth of Rio de Janeiro (SEE) and Sports Superintendence of the State of Rio de Janeiro (SUDERJ).

3.5 BRAZILIAN CHAMPIONSHIP

Para-Rowing

Esporte Clube Pinheiros (SP) was the big winner of the Brazilian Para-Rowing Championship 2018. The team from São Paulo was followed by Clube Aldo Luz (SC), in second position, and by the Flamengo Regatta Club (RJ), which finished third. The event was organized by CBR with CPB resources. The event took place at Raia da USP, in São Paulo, between the 6th and 8th of December. To In all, 45 athletes from 19 clubs were registered. Six events were played in the categories PR1, PR2 and PR3, plus two extra tests in the Junior B category with 10 registered athletes. On the day of the Finals, the Para-Rowing Brazilian started with the Double Skiff Mixed PR3 race. The double world champion Jairo Klug (Pinheiros) and Diana Barcelos (Flamengo) made the best time and took the first medal of the day. Following with Single Skiff, Renê Campos, from Salvador (BA) won the gold in the Single Skiff Male PR1 and Josiane Lima, from Aldo Luz (SC), won the PR2 Women's Single Skiff. In Junior Single Skiff Male B, Felipe Busato, from Clube Athletico Paulistano (SP), took the first position. And in Single Junior Female Skiff B, Ana Beatriz Florio do Pinheiros (SP) finished first. At the Single Skiff Men's PR2, Michel Pessanha do Flamengo (RJ) was the winner. The boat formed by the athletes from Martinelli (SC), Remo Adaptar (ES), Vitória (BA) and Pinheiros (SP) won the Gold on Four With Mixed PR3.

4. INTERNATIONAL CHAMPIONSHIPS

4.1 QUALIFYING RACE

Youth Games The Junior Team of the Brazilian Rowing Team was in Chile between 17 and 19/04 to to compete in the Qualifying Regatta 2018 Youth Olympic Games. The trip began on April 12, when four athletes and two technicians arrived in the country to participate in the FISA Junior Camp and train. In Female Skiff Single Isabella Ibeas qualified in the semifinal qualifiers A / B In the semifinal, was in the fourth position. Qualified for Final B, finished the race in seventh overall placement. No Two Without Male, With the duo Marcelo Ribeiro and Iago Costa, Brazil went straight to the Final because there were no qualifiers. The athletes conquered the 5th place. Rower Marco Misasi competed in Single Men's Skiff # 2 Eliminatory battery. Again in 2nd place in A / B Semifinal, Marco qualified for the Final A, finishing the race with the 4th best time. By the rules of the event, only the first three boats in each category would qualify for the Youth Games. However, Marco was confirmed to compete in your category. Despite finishing in fourth position, the Brazilian athlete won the vacancy left in opened by boat from Argentina. As Argentina had already qualified a men's boat during the 2017 Junior Rowing World Championship, the rule that the host country would have a guaranteed vacancy applied to the male tests. Thus, Marco's 4th place was also qualified to a place at the Youth Games.





4.2 SOUTH AMERICAN CHAMPIONSHIP

Rowing Junior and Under 23 The Brazilian Rowing Team ended its participation in the South American Championship of Junior Rowing and Under 23, held in Valparaiso, in Chile, with nine medals: four gold, three silver and two bronzes. Some evidence of this Championship also had a Pan-American character, due to the participation of athletes from all over the continent. Lucas Verthein Won Single Final A Men's Lightweight Skiff Under 23 and along with Uncas Tales Batista also won in Double Men's U23 Skiff. Uncas also went gold no Single Skiff Men's Under 23 Light Weight. The Brazil's fourth gold medal went to Renê Pereira, who won in the Single Skiff category Male PR1. Uncas also took a silver home next to Fellipe Reyson at Double Men's Under 23 Lightweight Skiff. The female paddle climbed the podium three times in Chile: first with Isabelle Falck, who won the bronze medal at Single Skiff Female Under 23 Lightweight, then Milena Viana, who took silver in the Single Skiff Female Under 23. The athletes paired in Women's Double Skiff Under 23 and back on the podium to receive the silver. Junior Men's Single Skiff Race, Qualification Race by Rower Marco Misasi has also been validated in the South American. Like Cuba's 2nd place boat, no participates in this championship Marco took to marries the bronze medal of the category.

4.3 SOUTH AMERICAN GAMES

Brazil ended its participation in the Games South American 2018 with four medals of bronze in the oar. The team of six athletes took the podium in the Double Skiff Finals Male Lightweight, Two Without Male, Women's Double Skiff Lightweight and Double Skiff Feminine. Disputes take place between the 27th and May 29, in Cochabamba, Bolivia. The pair formed by rowers Emanuel Borges and Evaldo Becker took the bronze in the Double Skiff Men's Light Weight (LM2x). Evaldo also teamed up with Aílson Eráclito on Two Without Male (M2-), conquering more a bronze for Brazil. In the women's team, Caroline Corado and Vanessa Cozzi took the bronze in Double Skiff Women's Lightweight (LW2x). Vanessa also played in the Women's Double Skiff (W2x), this time teaming up with Dayane Pacheco. The athletes won one more bronze medal for Brazil. In the individual events Vanessa Cozzi finished in fourth place in the Women's Single Skiff Lightweight (LW1x) and Emanuel Dantas on Friday Single Skiff Men's Placement (M1x). The Double Skiff Men's Boats (Emanuel Dantas, Aílson Eráclito) and Women's Single Skiff (Dayane Pacheco) were registered, but did not compete for their tests.

4.4 ROWING WORLD CUP STAGE 2

The 2nd Stage of the 2018 Rowing World Cup was held on the Linz-Ottensheim lane in Austria, between June 22nd and 24th, with over 700 registered athletes. Brazil ended its participation with two medals. The duo Willian Giaretton and Xavier Vela Maggi won the medal of Gold in Two Men Without Light Weight (LM2-) and rowing duo Josiane Lima and Michel Pessanha clinched silver in the Double Skiff Mixed PR2 (PR2 Mix2x). In the para-rowing team was also registered the athlete Renê Pereira in the Men's Single Skiff PR1 (PR1 M1x). The Bahian rower has finished in 4th position. In the Olympic team participated also the athletes Uncas Tales Batista, Lucas Verthein and Milena Viana. Uncas disputed the test Single Skiff Men's Lightweight (LM1x) and finished in 3rd place of Final B. Lucas was with 5th place in Men's Single Skiff Final D (M1x). And





Milena played in Single Skiff Female (W1x) and reached 6th place in Final B. Willian and Xavier also played Two Without Male (M2-), finishing in 10th place. The Brazilian Rowing Team traveled on a mission organized by CBR. The olympic athletes were accompanied by the Technical Coordinator, Marcello Varriale, and the coach of Botafogo (RJ), Paulo Vinicius Alves de Souza. In the Paralympic team, the athletes traveled accompanied by the Guilherme Soares and the physiotherapist Rafael Jacob.

4.5 ROWING WORLD CUP STAGE 3

The last stage of the 2018 Rowing World Cup happened in Lucerne, Switzerland, between the July 13th and 15th. The Brazilian Rowing Team was registered with five athletes in four races, the Brazilian rowers came to the C and D Finals Rower Milena Viana competed in the Women's Single Skiff (W1x), ending her participation in the 4th place of Final C. The Young Under 23 athlete has shown good progression in international competitions. The duo Willian Giaretton and Xavier Vela Maggi represented Brazil in Two Men Without (M2-), ending the dispute in the 3rd place of the Final C, 15th place overall of the category. The athletes, originally Lightweight, demonstrated good conditions in the race, competing in equality with the group that competes for Olympic qualification next year and with good prospects for the 2019 Pan American Games. Uncas Tales Batista competed in the Men's Single Skiff (M1x) race and finished in 6th place Final C. The Under 23 Lightweight athlete, even participating in the open category, resulted in positive considering being in preparation for the U23 World Cup. In the same category the athlete Lucas Verthein was enrolled, who finished in 6th place of Final D. Lucas also took advantage of the World Cup in preparation final for the World Cup.

4.6 U23 WORLD ROWING CHAMPIONSHIP

Brazil ended its participation in the World Rowing Sub 23 2018 with an unprecedented result: Uncas Tales Batista was double world champion in Category Single Skiff Men's Light Weight Sub 23 (BLM1x). Uncas repeated the podium won in 2017 and became the first Brazilian rower to win a world championship by two consecutive times. In addition to Uncas, Brazil was represented in the U23 World Rowing Championship 2018 for two more athletes: Lucas Verthein in Men's Single Skiff Under 23 (BM1x) and Milena Viana in Single Skiff Female Under 23 (BW1x). Lucas finished his participation with 6th place in Final A. The rower had won 11th place in 2017, evolving this year five positions in the ranking of category. Milena took the 9th place overall of the category. By 2017, she had finished 18th position, showing good progress. The title of double champion won by athlete Uncas Tales Batista brought great visibility for the national oar. The news was featured in several long range vehicles including Globo Esporte, UOL, ESPN and the Committee's website Brazilian Olympic Games. The good results of the Brazilian National Team were also announced by supporters. CBR's social networks had over 60,000 views during coverage World Cup 23 and the podium video was seen by over 10,000 people.

4.7 JUNIOR ROWING WORLD

The representative of the Brazilian Rowing Team, Marco Misasi, ended his participation in the Junior World Rowing Championship 2018 with 2nd place in Men's Single Skiff Final C (JM1x), 14th place overall in the category. The event happened in Racice, Czech Republic, between





August 8th and 12th. Marco started his participation in the world 2nd place in your Eliminatory battery. The Brazilian remained in third place up to 1500 meters, then increased the vogue and finished only 0.35 seconds behind the first placed. In the quarterfinals, ended in the 4th placement of your battery. At the C / D Semifinal, Marco secured the first placement and qualified to compete in the Final C. The fight for first place in the Final took place over the last 500 meters but the Canadian boat managed to cross the finish line 1.38 second before the Brazilian rower. This was the athlete's first participation in a world championship. The athlete was in Racice accompanied by coach Vanessa Varga, from Pinheiros (SP). At airfare, lodging, food, boat rentals and insurance were paid by the CBR through funds from the Agnelo / Piva Sports Support Law. The used boat in the tests was from Italian manufacturer Filippi.

4.8 SENIOR ROWING WORLD

Another unprecedented achievement for Brazilian rowing in 2018: duo Diana Barcelos and Jairo Klug was double champion in the Double Skiff Mixed category PR3 (PR3 Mix2x). The Brazilians repeated the 2017 result and conquered again the gold medal at Senior Rowing World 2018. The event was held in Plovdiv, Bulgaria, from 6 to 9 September. In all, eight athletes were summoned to the 2018 Senior Rowing World Championship. For rowing, the pair Josiane Lima and Michel Pessanha took 4th place in Double Final A Skiff Mixed PR2 (PR2 Mix2x). Both athletes also competed in the category Single Skiff PR2. Josiane took 5th place in Single Skiff Women's PR2 (PR2 W1x) and Michel in 5th place in the Men's PR2 Single Skiff (PR2 M1x). Rower Renê Campos played in Single Final Men's PR1 Skiff (PR1 M1x) and also stood with the fifth place in the category. In the Olympic team, two boats competed evidences. The duo Willian Giaretton and Xavier Vela Maggi took 5th place in the Two C Final Sem Male (M2-), 17th place overall in the ranking of category. Rower Milena Viana has finished in 1st place of Final D in Women's Single Skiff (W1x), 20th in the category ranking. The double championship won by the duo Diana Barcelos and Jairo Klug at the Rowing World Senior 2018 brought great results to the disclosure of the Brazilian oar. The posts of the championship hit record shares on Facebook and views on Instagram, with over 22,000 hits.

4.9 WORLD ROWING MASTER

Between September 27 and 30, athletes from 25 Brazilian clubs represented the country in the Master Rowing World Championship 2018, held in Sarasota-Bradenton, United States United. The event received almost 2000 athletes in 445 races in the 13 rowing categories. Master Fifteen Brazilian boats conquered first place in your tests. The 25 Brazilian clubs registered were: Aldo Luz (SC), Bandeirante (SP), Admiral Barroso (RS), Botafogo (RJ), Cabanga (PE), Potengy (RN), Regatta Club Curitiba (PR), Naval Club of Brasilia (DF), Alvares Cabral (ES), Corinthians (SP), Crossrowing (DF), Rio de Janeiro Rowing Club January (RJ), Guaíba-Porto Alegre (RS), Grêmio Union (RS), Guajará (PA), Martinelli (SC), Paysandu (PA), Piraquê (RJ), Rowing Adapting (ES), Riachuelo (SC), San Salvador (BA), Union (RN), CEPEUSP (SP) and Vasco da Gama (RJ). To compete in a Master event, the rower must be at least 27 years old and have not participated in competitions in the Senior category for at least a year. The evidence of Master are performed in divided categories by age, all within 1000 meters, being the last category for athletes over 89





years old. In the group of octogenarian athletes, the oldest was the Brazilian Odilon Maia Martins, 89 years old.

4.10 YOUTH OLYMPIC GAMES

On October 10, the evidence of rowing at the 2018 Youth Olympic Games. Brazil was represented by athlete Marco Misasi, who finished in Junior Male Single Skiff (JM1x) with the 10th overall position of the category. At races took place between 07 and 10/10 at the from Puerto Madero in Buenos Aires. The event format was different compared to to other international rowing competitions. At The playoffs were played in three rounds: first the athletes competed time trial on a 900 meter course with a curve of 360 ° in half. Then two disputed 500 meter rounds. The Brazilian got 13th position in the race against the clock. In Round 2, he got the 3rd position on your battery and the 3rd Round with the 2nd position, totaling 7 points in total. Like this result, Marco went to the quarterfinals, finishing in 4th position and ranked for the Semifinal C / D. With first place on the drums of the Semifinal, played in the Final C and won the 2nd place, ending its participation with the 10th overall place in the category. Marco traveled with his coach Vanessa Varga, from Esporte Clube Pinheiros (SP), in a mission organized by COB. Vanessa "Although it was not an event in the official 2000-meter format, it was a great experience. Very well organized as well disputed and great for Marco who needed get rid of some habits and reset some concepts to get into the tests."

4.11 WORLD ROWING COASTAL

The rowers André Dutra and Adriano Miranda, Clube Aldo Luz (SC), participated among the October 12th and 14th at the World Rowing Coastal Championships 2018, 12th edition of the World Coastal Rowing organized by FISA. The event happened in Victoria, Canada. The Brazilians finished 13th in the Double Skiff Men's Final B (CM2x). The duo, despite being paralympic, rowed in the Olympic category. Coastal rowing evidence (or coastal) are performed within a distance of 4 kilometers, with a delimited route by buoys that must be bypassed by boats, similar to a sailing event. The coastal paddle is a relatively new class where boats have reinforced structure and are prepared to face waves and strong winds at sea. Athlete André Dutra traveled with resources FUNDESPORTE Program of the Secretariat of Tourism, Culture and Sport of the Government of Santa Catherine. The athlete Adriano Miranda received support Ullys Orthopedics, Florianópolis.

4.12 QUALIFYING RACE TO THE 2019 PAN AMERICAN GAMES

Brazil ended its participation in the Pre Pan, 2019 Pan American Games Qualification Regatta, with four silver medals and one of bronze. In addition to the medalists, eight more Brazilian boats obtained results for classification to the Pan American Games. The event happened in Rio de Janeiro. On Saturday, the first day of Finals, the boat formed by the athletes Samuel de Mello, Fabio Moreira, Pedro Henrique Drummond and Vinício Delazeri, won 2nd place in the Final The Four Without Male (M4-). The duo Lucas Verthein and Evaldo Becker took 2nd place in the Men's Double Skiff Finals (M2x). Lucas also secured second place in the Final Single Skiff Men's (M1x). On Sunday, the second day of Finals, the boat Four Men Without Lightweight (LM4-) formed by athletes Emanuel Borges, Vangelys Renke, Renato Cataldo and Marcos Oscar Alves, won the silver medal. And the duo Willian Giaretton and Xavier Vela Maggi took the bronze in

Two Without Male (M2-). The 2019 Pan American Games will be held in Lima, in the Peru, between July 26 and August 11. The Pre Pan was organized by the Rio Regatas Organizing Committee in partnership with FISA, CBR, Rio de Janeiro and Navy Rowing Federation of Brazil. The event was supported by the Absolut Sport and Kilogram companies. Through Under the Agnelo Piva Act, CBR paid for arbitration, uniforms, boats, medals, credentials, T-shirts and other overheads.

5.TECHNICAL DEPARTMENT

5.1 Training Course of Rowing Coaches

The Brazilian Rowing Confederation held in Aracaju (SE), between 30/03 and 01/04, the 1st edition of the Training Course for Rowing Coaches. The classes were taught by Fernando Carvalho, who presented to the participants the methodology of the new Rowing - Athlete Capture Model. In addition to the methodology for capturing new athletes, the course trained participants in the basic regulation of school boats, motor learning techniques in the initiation of rowers, boating and rowing with safety, stretching basics, safety and dangers in rowing lessons. The classes were 50% theoretical and 50% practical. Fernando Carvalho is a FISA Level II Technician (International Rowing Federation), specialist capturing new talent with extensive experience in this successful international model. Fernando also oversaw the development of the Rowing Guide - Capture Model of Rowing Athletes, CBR publication aimed at for clubs and federations. The course was conducted in partnership with Sergipe Rowing Federation, at the initiative of the president José Geraldo Porto who is bringing more knowledge to profissionalize the oar in the state. Successful students are qualified to work in rowing clubs as school coaches (for rowers of beginner level). After the end of the classes, the participants answered a questionnaire to course and teacher evaluation.

5.2 COMPLETE COURSE FOR REFEREES FORMATION

During the month of April, CBR held two editions of the Complete Course for National Referees. The first was held in Belém, in partnership with the Paraense Federation (FEPAR), and the second in Rio de Janeiro, in partnership with the Rio de Janeiro Rowing Federation January (FRERJ). In July it was Recife's turn to receive an edition of the course, held in partnership with the Pernambuco Rowing Federation (FPR). The Belém course took place at the Hotel Sagres, with theoretical classes between the 18th and 4/20. On April 21, the test was held practice for qualification in the Tourist Complex See-O-Rio. In the Rio de Janeiro edition, the classes and practical test took place between the 24th and April 29, at the FRERJ Training Center, located at the Remo da Lagoa Stadium. In Recife, the classes and practical test took place in Cabanga Yacht Club between 17 and 21/07. Classes were given by the Principal Arbitration Arbitration Panel and FISA Arbitrator, Magali Moreira. Content prepares the student to act in all referee positions within a race: control committee, starting referee, aligner, referee, arrival referee and chairman of the jury. After the course, students need pass the written and oral examinations for who can act as rowing referees in official events of the confederation. In 2018, 20 new referees were qualified in the three editions of the course. In all, since 2014, CBR held the course in 11 states and trained 99 referees. The referees approved in previous courses may participate again for recycling and updating knowledge.

5.3 TRAINING CAMP

The CBR held in Rio de Janeiro, between the May 8 and 20, a training camp for Senior Athletes of the National Rowers Group. Thirty rowers participated in this field and nine rowers selected from their results at the National Selective SNAR periodicals. Field activities were focused on water training to test garrisons Long boats. The athletes also performed the SNAR ergometric assessments expected to the period. Trainers had the opportunity to cross garrisons with objective of testing possibilities and standardizing group technique. The athletes were trained by a team formed by six technicians. In the male team, the double palamenta drills were in charge of the technicians Alexandre Monteiro (Botafogo, RJ) and Paulo Vinicius de Souza (Botafogo, RJ). In the simple were Alexandre Rosa (Vasco da Gama, RJ) and Maurício Abreu (Flamengo, RJ). Already the team The women were in charge of Alexandre Nunes (Pinheiros, SP) and Leonardo Cortes (Flamengo, RJ). The Training Camp was organized by CBR Technical Coordinator, Marcello Varriale. Marcello explained that during training In the water and in the remoergometer assessments were made for the formation of the Qualification of the 2019 Pan American Games, held in late November in Rio de Janeiro.

5.4 QUALIFICATION FOR WORLD CUP

Between May 14 and 21, three athletes from rowing riders were at the USP Olympic in São Paulo, to participate in training and time taken for qualification in Stage 2 Rowing World Cup 2018. The three participating athletes, Renê Campos, Michel Pessanha and Josiane Lima, achieved good results and were summoned for selection. The training took place between the 14th and may 17. May 18th, 19th and 20th were three time taken for measurement Index As previously published in Technical Bulletin 05/2018, athletes would need reach the average bronze medal index in the Paralympic boats of official competitions of FISA of the year 2017 to be called at the 2018 Rowing World Cup. In the boat Single Skiff Men's PR1 (PR1 M1x), the rower Renê Campos Pereira did not reached the mark set in the bulletin, but his results were close, proving the athlete's evolution. Thus, his participation was confirmed in the Brazilian National Team. At the Double Skiff Mixed PR2 (PR2 Mix2x), the double Josiane Lima and Michel Pessanha had time within the established index. The boat Four With Mixed PR3 (PR3 Mix4 +), which was planned in training, could not participate due to injury of one of the athletes, who would not recover in time for the activities. The athletes were accompanied by the CBR Technical Commission formed by the para-rowing coaches Guilherme Soares and Fernando Carvalho, by physiotherapist Rafael Jacob and boatman Ricardo Araújo. Athletes and professionals were





hosted at the Brazilian Paralympic Center in São Paulo. The team also received support from César Moreira, from the Remo Meu Institute Towards, during activities at CEPEUSP.

5.5 PARADESPORT CONGRESS

The Brazilian Rowing Confederation was present at the VI International Paradesport Congress, one of the largest events in the world about scientific and technological innovation in sport Paralympic. The event took place between the days November 1st and 4th at Training Center Paralympic Games, in São Paulo, with more than 1100 from different countries. Among the 258 papers presented in the event was the article written by the tech of CBR para-rowing, Guilherme Soares, in partnership with physiotherapist Rafael Jacob, physiologist Rafael Passatore and sport scientists Ciro Winckler and Tiago Lourenço. The work "Performance Responses of National Team Athletes Brazilian Rowing in the distance of 2000 meters PR1 M1x and PR2 Mix2x boats with and without use of rhythm feedback "analyzed the result of athletes at the new distance of 2000 meters. The event was organized by the Academy Paralympic Association (BPA), the educational arm of Brazilian Paralympic Committee (CPB). The congress had short courses, round tables and training conferences, training of high performance and studies of sports mobility, among other umlauts. In the activities on sports management, administrative assistant CBR, Marisa Braga attended the course of "Project Modeling".

5.6 PARALYMPIC TRAINER CLUB

On July 2nd, happened in Blumenau the launch of the para-rowing modality in the Paradeport program of the municipal government. The initiative works as a pilot of the Paralympic Training Club, a rowing project adapted from CBR It will be carried out through the Secretariat Municipal Education and Municipal Foundation Sports, in partnership with CBR, América and Blumenau Paradesport Association. The technician attended the ceremony. CBR para-rowing officer Fernando Carvalho, the director of the Blumenau Paradeport Association (APESBLU), Giselle Margot Chiroll, the mayor Blumenau, Mario Hildebrandt, the Secretary of Education, Patricia Lueders, and the rowing technician of the Nautical Club America, Roque Zimmermann. The Paralympic Trainer Club project is a CBR's long-term initiative with the objective of develop poles for training and identification of para-rowing talent. Blumenau was chosen as pilot headquarters due to the engagement of public power in sport. The experience gained in Blumenau will serve as a model for expansion of the project in other cities. "I did research on the rowing poles that we have all over Brazil and found several initiatives where Blumenau was a highlight in the sport, I also saw the engagement of the government and the identification that the city has with the Club Nautical, so I understood that this would be the right place to start, "explains the CBR technician, Fernando Carvalho Classes will take place at Clube Náutico América, on the Itajaí-Açu River, for disabled people from 12 years old and able to swim. Project teachers, including America's technician shall be borne by the Municipal Secretariat of Education. Athletes with potential will be invited to the CBR camps and events. The project's first student, Bruna Cristina Gomes de Araújo, held an inaugural class during the launching ceremony. CBR gave in a boat adapted for use during classes Coach Fernando Carvalho will visit monthly to the project, providing technical support, guidance and assessing the progression of athletes participants of the Training Club.





5.7 CLASSIFICATION WORKSHOP FISA FUNCTIONAL

Between 06 and 07/12 of 2018, the CBR and the Brazilian Paralympic Committee (CPB) held the FISA Technical and Medical Functional Classification Workshop. There were 14 classifiers four in the Medical and ten in the Technical category. The classes were given during the Para-Remo Brazilian 2018, held at USP's Raia in São Paulo. CPB supported CBR through the program Paralympic Education, a partnership that seeks to bring training opportunities and updating of knowledge through qualified professionals. The classes were held at the Brazilian Paralympic Training. The workshop also featured the seal Federal University of Uberlandia, through Faculty of Physical Education and Physiotherapy (FAEFI). A total of 10 hours of contente distributed in five classes. The classes were taught by the Level 1 Technical Classifier FISA Eliana Mutchnik and the Classifier National Physician Dr. Adriana Vidal.

- 6. MARKETING AND COMMUNICATION

6.1 Internet Results

During Season 2018, CBR maintained its good results that have been obtained in recent years with the online dissemination of events and of the entity's activities. In addition to the website and Facebook, already used since 2014, the online presence has been expanded to Instagram,





Twitter and YouTube. On the site, the number of visitors remained practically stable at 32,596 visitors in 2017 to 32,053 visitors in 2018. You can see the peak visits on the site of CBR are directly linked to the events nationals. During Brazilian Short Boats 2018, for example, the site registered an increase 150% in the number of visitors. The pages Results, Bulletins and Calendar are among the most accessed from the site since 2014. By 2020, an increase in visits is expected, as occurred in 2016 during the period before the Olympic Games. On Facebook, the number of followers has doubled since 2014, but the reach of News last year fell 42% and average views per post dropped from 1042 to 719. This is a reflection of the fall in the number of Facebook users who are migrating to other social networks. Note mainly the drop in number of young users: in profile Remo Brasil, 60% of the active public has more than 35 years old. Engagement and reach of publications is also linked to the results of the Selection Brazilian at international events. During the Under 23 World Cup 2018, when Uncas Tales Batista won his two-time title, Facebook was the highest of the season: 36,412 people. In the Third Stage of the World Cup Remo, when Brazil arrived ended its participation in Finals C and D, were only 6,089 People reached. Remo Brasil Instagram Profile, released March 2018 had a similar range to even though it has less time to Usage: 125,846 people. View Average per post was 1301, 80% higher than Facebook in the same period. The increase of this number will depend on a larger generation of content by CBR: news, photos and videos that consequently generate more visibility for the Brazilian oar. Another highlight was the use of videos in the online dissemination. Publications with up to 4 times the range during the Junior World with photos. In the Senior World, the videos had range up to 8 times longer. In Facebook alone, there were 18,500 views of the videos posted. Remo Brasil YouTube channel had 3.1 thousand video views with the stream from Pan American Qualifying Race.

RELATIONSHIP BETWEEN CBR AND THE ROWING COMMUNITY

6.2 STATE ROWING DISCLOSURE

CBR continued with its outreach support to state federations during 2018. There were 32 news articles published on the site and on the networks. Confederation social groups totaling over 190 news since 2013. Website content is also periodically routed to the list. CBR contact information, which includes former rowers, sports authorities and journalists. Medals were provided at cost price for the federations concerned. CBR closed a large order from your supplier and managed to keep the price below the market average including freight for delivery throughout Brazil. There were 1,896 medals sent to 32 competitions in eight states: Amazonas, Bahia, Federal District, Espírito Santo, Pará, Pernambuco, Paraná and Santa Catarina.

6.3 OPINION POLLS

Following guidance from the Olympic Committee, the CBR started in Season 2018 the realization of opinion polls about national events and missions to international events. Athletes and coaching staff had the opportunity to evaluate the work of the Confederation and suggest changes for improvement in activities and events. In the Brazilian Short Boat 2018, held at Raia da USP in March, the evaluation of the participants was very positive: the event received an overall rating of 4.0 out of 5.0 points. The participants were 32 athletes and technicians from five





states. The research was carried out anonymously and could be evaluated nine items: Location, Streak Structure, Date, Boats, Medals, Organization, Disclosure, Arbitration, and Access to Newsletters. The most highly evaluated items were the Streak Structure and the Championship Venue (São Paulo), with grades 4.7 and 4.6 respectively. The Survey participants praised the beacon in the USP Raia. According to a coach who answered the survey, "the streak allowed all athletes competed equally." The beacon started at the end of 2017 and was finalized for this championship by CBR in partnership with CEPEUSP and CPB. Some points critics were raised and evaluated in the planning of the following championships. In the item Disclosure, several suggestions were received to broadcast the event via the internet. The Brazilian Longboat Championship 2018, held in October in Rio de Janeiro, It also received positive evaluation from the participants, obtaining an overall score of 4.2 points. The survey was answered by 40 people. 34 athletes and 16 coaches / club officers subscribed. The answers were anonymous, but the participants indicated the membership club in way that the result represents the opinion of 17 clubs from eight states. The most highly rated items were Access to Bulletins (note 4.6) and Streak Structure (4,5). The points indicated for improvement were Boat Availability (3,8) and Disclosure (3.2). No specific issues were raised by participants in the space for research comments. On social networks, we get the suggestion of simplifying the dissemination of the results to make it easier for viewers still lay in the oar. In research conducted with athletes and technical committee convened for the events the general note for the mission of the South American rowing in March was 3.0 points. Participants were able to evaluate nine Items: Airport to hotel transfer, Transportation for training, food at the competition venue, food at the competition venue, accommodation, uniforms, technical staff, boat and general organization. Athletes reported problems with eating at the competition venue, with the regulation of the boats and the size from car to transport. Hosting and staff technique received praise. In World Cup Stage 2 in June, the grade increased to 4.4 points. In the World Junior, the grade was 4.1 points and in the World Senior 4.0 points. The criticisms in these cases were mainly in relation to the uniform, which presented problems due to confection. Unfortunately not all athletes and commission technique responded to the survey, which would allow CBR to better identify problems and present more assertive solutions.

6.4 SUPPORTERS

For the international competitions held Between June and August, all the athletes summoned received a kit that included Certificate Convocation Officer, Remo Brasil T-Shirt, Mormaii uniform and Hydrotank termos by Urbnsol. The companies Mormaii and Urbnsol acted as supporters of the Brazilian team Remo and provided the products at no charge. The T-shirt and certificate were paid from the Confederation's own resources. The Urbnsol brand was very participative throughout the support period. She disclosed the results of the selection in their networks and if showed open to new partnerships, because there is interest in combining its image with sports. The value invested by the supporter was R \$ 1,305.00 in products sent to athletes. Mormaii released the medalists from selection your website, Facebook and Instagram, with highlight to the photos of the Paralympic boat with the Mormaii logo. The mark also appeared on FISA website on photos of Paralympic Finals A during the World Cup. The amount invested by the





supporter was \$ 9,600.00 in products. The value is approximate based on the average value of product market (34 unisuit).

Technical Pronouncement CPC 27 - "Property, plant and equipment" requires depreciation be calculated based on rates that take into account the expected life of the goods. Additionally, the entity has no individual control. On the assets recorded in property, plant and equipment. There is also donation of boats received after Pan American championship whose boats are owned and held by the Confederation, but are not recognized in the balance sheet. Of the entity. Consequently, we were not appropriate and sufficient audit evidence regarding the asset balances depreciation as of December 31, December 2018, with a net balance of fixed assets of R \$ 1,700,941.62. Our audit was conducted in accordance with Brazilian and international auditing standards. Our responsibilities, accordingly with such standards are described in the following section entitled "Auditor's Responsibility for audit of the financial statements". Are Independent in Relation to Confederation in accordance with the relevant ethical principles Professional Code of Ethics and the Professional Standards issued by the Board Federal Accounting Office - CFC and comply with other ethical responsibilities in accordance with these standards. We believe that the evidence of audit obtained is sufficient and appropriate to substantiate our opinion.
