1.1 INTERNATIONAL UNDERSTANDING

International rowing events and meetings are organized in order to be a friendly contact between participants, contributing to a better understanding between people and nations, regardless of race, gender, nationality, beliefs or political system. Rowers form a worldwide family based on the ideals of peace, friendship, justice, understanding and mutual help. All rowers are encouraged to foster an international understanding through the practice of rowing.

1.2 INDIVIDUAL DEVELOPMENT

Through rowing, the individual acquires a personal experience of determination, team spirit, respect, responsibility, integrity and a sense of fair play. Applying these principles in all circumstances, rowers become independent and responsible individuals, prepared to face the reality of life.

1.3 ENVIRONMENTAL RESPONSIBILITY

Rowing is a sport that requires clean air and water. The Remo community has an important role in the sustainable management of natural and social resources, especially those that are necessary for the practice of rowing.

1.4 SPORT FOR ALL

Rowing allows the maintenance of good physical condition at all ages. Rowing is a competitive and recreational activity regardless of age, gender or skill.

WOMEN ON THE ROW

GROWTH OF PARTICIPATION FEMALE IN ROWING IN 2020

2.1 FEMALE ROWING IN BRAZILIAN SHORT BOATS

The 2020 edition of the Brazilian Short Boat Interclub Championship (CBI), held at USP's Olympic Lane, marked the consolidation of Brazilian women's rowing. For the second consecutive year, the competition repeated the number of registered athletes (65), showing that Brazil follows a world trend that is to open up more space for women in rowing.

"This competition has the meaning of being a door that opens, of being able to join a selection, to make a career as a sportsman. As the female paddle has been around for less than the male paddle, we have been suffering for a while from the small amount of boats, less amount of evidence for women, but it is improving. Today, in this Brazilian, I see a balance between the two genders ", said coach Letícia de Oliveira, from Corinthians (SP).

By the way, she is also a pioneer in the sport. She says she knows few techniques that work on rowing. "Besides me, I only know three others. We are also opening doors for other coaches to see that they can work with any athlete. It is equal to equal. My team respects me a lot, regardless of being a woman, "says Letícia.

For older athletes, the current reality in Brazilian tournaments shows a great evolution. "When I started here in São Paulo, there were no qualifiers, it was a direct final. We needed to gather girls from other categories and weights to form a final. In Flamengo, today we have a lot of girls in the paddle ", explains Vanessa Cozzi, from Flamengo (RJ), who competes in Single Skiff.

Among the representatives of the new generation, Maria Misasi, from Corinthians (SP), 14 years old, celebrates the opportunity to play in a tournament of this level. "It is a learning opportunity. Even knowing that I still don't have great results, it is very important to be able to be on the same streak of athletes that inspire me ".

SAO PAULO

FEBRUARY 05 TO 09 RAIA DA USP (SP)

3.1 CBI OF SHORT BOATS

The city of São Paulo received the opening of the Brazilian rowing season with the holding of the Brazilian Interclub Championship (CBI) of Rowing Short Boats 2020, between the 5th and the 9th of February, at USP's Olympic Streak. 191 athletes representing 24 clubs from ten states in Brazil were in action.

The competition was divided into two phases. Between the 5th and 7th of February, there were the qualifiers, recaps, quarterfinals and semifinals. On the 8th (Saturday), there was the definition of the winners of the Brazil Trophy, in which disputes are by type of boat, regardless of age, defining the champions of Single Skiff and Dois Sem, in both genders. Flamengo (RJ) and Corinthians (SP) ended up leading the conquests of this phase, with two victories each, while Botafogo (RJ) won a competition.

On the 9th (Sunday), the CBI of Short Boats took place, when the six fastest boats, according to the results in the qualifying phases, disputed the finals by category. Flamengo (RJ) was the great champion.

The Rio club was the favorite to take the national title and confirmed expectations, ensuring the third championship with a total of 11 events, adding to those obtained on Saturday (8), in the final of the Brazil Trophy. Botafogo (RJ) took the runner-up, with seven golds, and Corinthians (SP) took the third place, with two victories in the two days of the finals. CBI had as a partner in the realization of this event the Brazilian Club Committee, which provided transportation and accommodation for the clubs and technical team.



3.2 1st REMO BRASIL DE REMO INDOOR CHALLENGE

The first edition of the Remo Brazil Indoor Rowing Challenge 2020, an online event created by CBR to engage rowers from all over the country during social isolation, was very well received by the rowing community. Altogether, 119 athletes in 11 categories participated in the challenges, there were four stages and more than 450 individual tests performed at a distance.

The event consisted of completing four challenges on the remoergometer. Each week, CBR released a new test through social networks and the participants had until the following week to send the results. According to the ranking of each week, the athletes received points for the general ranking, where the winners were known.

The clubs Flamengo (RJ) and Martinelli (SC) were the highlights in the final ranking, conquering six and four victories respectively. Athletes from 28 clubs, associations and gyms participated in the Remo Brasil Challenge, in addition to those registered independently. The reach of the event went beyond what was expected by CBR, reaching ten states and even participants from other countries.

3.3 2nd CHALLENGE REMO BRASIL DE REMO INDOOR

After a long journey that crossed three continents and more than 17,000 meters, the winners of the 2nd Remo Brasil Indoor Rowing Challenge 2020 were known. In this edition, CBR was inspired by the main rowing strips in the world to create five challenges, disputed by 08/12 to 09/15 by 122 participants.

The athletes from São Paulo and Santa Catarina led the ranking of categories and were the champions in general. CN Francisco Martinelli (SC), from Florianópolis, won four categories, repeating the result of the first edition of the event. Then, EC Pinheiros (SP), from São Paulo had three victories and CN América (SC), from Blumenau, two victories. This edition also had winners from Espírito Santo, Pará, Rio de Janeiro, Rio Grande do Sul and Argentina.

The top of the overall ranking was from Esporte Clube Pinheiros (SP), with Alina Dumas winning in the women's and Olavo Vinicius Pelegrino winning in the men's. In second position, Santa Catarina double: Giulia Renata Alves dos Santos, from Clube Náutico América (SC) was female vice-champion and Adriano João Teixeira, from Clube Náutico Francisco Martinelli (SC), was male vice-champion.

For the event's award, illustrator Henrique Neumann created an exclusive print inspired by the tourist spots of the cities where the challenge's lanes are. The companies Hawk Sports and Tritengo were supporters of the event and suppliers of the award items.

PLANNING AND DEFINITION TRAINING POLES

4.1 ROW FOUR PROGRAM

In 2020, CBR started the Remo Quatro Program, an initiative to map Olympic talent in the grassroots categories and synchronize the training of these athletes in a national project. The program selects rowers and rowers from the Junior and Sub 23 categories to compose boats Quatro Sem, Quatro Com and Eito Com.

The main objective of the program is to form garrisons to compete for the Brazilian Rowing Team in the continental and world championships of the base categories. In addition to following a national training program, athletes and coaches participate in regional and national training camps to exchange experiences.

Remo Quatro aims to enhance the Junior and Sub 23 categories, identifying young talents through the monitoring of standardized indicators. The coaches of the selected athletes will be represented in the program through regional technical leaders, who will communicate directly with the project leaders.

For the first phase of implementation, the five selected centers were: Belém, Natal, Salvador, Florianópolis and Porto Alegre. Also selected were the leading technicians of each region and the ambassador athletes, who have a noble mission to inspire young rowers from their region of origin. The choice was made in conjunction with the state federations and the clubs that submitted their application.

After the launch of Remo Quatro in late May, CBR began an intense process of virtual meetings with interested clubs. More than 50 people participated, including coaches, club managers and federation officers, adding up to more than 70 hours of work over 5 weeks. The discussion about rowing in the states resulted in strategic planning for each region with a focus on the growth of rowing.

TEAM TRAINING PROGRAM TECHNIQUE

4.2 TECHNICAL TRAINING

Between July and August, a series of open classes from the Remo Quatro Program was held. There were six meetings with a total of 135 registrations. The classes were part of the training of the regional leader technicians who work in the program.

The first class, 07/07, was with the technical manager of CBR, Marcello Varriale, who talked about regulating boats. On 07/20, the national leader of the Remo Quatro Program, Oguener Tissot, held a class on team building and club planning.

The next guest, on July 27, was Dr. Fernanda Donner, a nutritionist and specialist in sports nutrition. On 07/30 it was the turn of Letícia Muziol, national leader of the Remo4 program and coach of Corinthians (SP). Along with Marcello, the conversation was about paddle safety. Water hazards, equipment and responsibilities were discussed.

On the same date, Marcello and Leticia talked with the participants about the prevention of harassment, discrimination and violence in rowing. On 07/31, Marcello took a class focused on management strategies for rowing clubs. This was the meeting with the most registrations received, 108 in total, showing the importance of this issue for the rowing community. Finally, the last class on 08/04 received the osteopath Rafael Jacob as a guest.

The six online classes totaled 10 hours of free training offered by CBR to the entire rowing community and other interested parties. The recorded lessons were made available on Remo Brasil's YouTube channel.

Between 11 and 18/10, the first Regional Training Camp of the Remo4 Program took place. In all, 82 athletes participated in training in five centers, following a unified training plan and defined by the National Leading Coaches.

The CBR Technical Coordinator, Marcello Varriale, congratulated the commitment of the technicians in the CTs: "I lack words to describe the success of this first practical accomplishment of such a large project, with so many people involved and that will certainly take on gigantic proportions. I am sure that the young people who participated, as well as the technicians, experienced something constructive and that will motivate them to seek new limits. " This was Remo4's first face-to-face activity, which started in May, during the pandemic.

4. REMO4 PROGRAM



OCTOBER 15-18 22 PARTICIPATING ATHLETES



At Polo PA, the CT was held in Belém, between 15 and 18/10, with the participation of 22 athletes from the Guajará (PA), Clube do Remo (PA) and Paysandu (PA) clubs. The activities were commanded at a distance by the Regional Leader Technician, Luiz Felipe da Silva, assisted by the technician Tony Marques, who led the project.

For the rower Elias Silva Nonato, from Paysandu, the experience "was very different, but I really liked it. I feel better prepared to face other challenges. " He also says that he was able to understand which aspects he needs to work on more: "Improve my time and my psychological, because that gets in the way."

Rychelly Leandra Freira, from Clube do Remo, understood that she has the potential to improve: "I am young and I know that I have a lot to learn from this project. It is a great satisfaction to be able to participate in an event of this category, which had the union of the clubs and everyone was there to reach the goals. In all these years of rowing we have never had an event of this magnitude."

CT POLO SC / PR

OCTOBER 11-17 21 PARTICIPATING ATHLETES



The Polo SC / PR CT took place in Florianópolis, from 11 to 17/10, with the presence of 21 athletes from the clubs Aldo Luz (SC), America (SC), Clube de Regatas Curitiba (PR), Martinelli (SC) and Riachuelo (SC), in addition to an athlete from Botafogo (RJ) and an athlete from Vasco da Gama (RJ), residents of the capital of Santa Catarina. Along with the Regional Lead Technician, Roque Zimmermann, five other technicians participated in the training.

Athlete Emily Julie Antunes de Souza, from CRC, says she has evolved a lot during the seven days of training: "It was an incredible experience to be able to paddle with seven more girls and see that the female paddle is growing! I evolved a lot, I even managed to row both sides."

For coach Marco Moreira Martins, from Martinelli, the experience allowed coaches to teach the importance of teamwork and show how rowers can develop in the long run. "From the first day, there was engagement and exchange of experience. We also put them in situations of discomfort, such as changing board, so they can see other ways of rowing."

CT POLO RS

OCTOBER 15-18 16 PARTICIPATING ATHLETES



The Polo RS CT took place in Porto Alegre, from 15 to 18/10, with the presence of 16 athletes from the clubs Centro Português (RS), Grêmio Náutico União (RS) and Guaíba-Porto Alegre (RS), in addition to six athletes Flamengo (RJ), residents of Pelotas and currently affiliated to the Rio de Janeiro club. Under coach Oguerner Tissot, four other coaches participated.

One of the athletes summoned was Mariana Macedo, from Flamengo, who is also an ambassador athlete. For her, "the interaction between the clubs, the federation and the coaches was very good, all working together. I'm sure that the next camps will also be very cool."

Coach Manoel Hoff Azzi, from Grêmio Náutico União, says that "the club was very happy to be able to host the polo and we are already thinking about the next meetings. It was four days of a lot of training and a lot of learning. We had a lot of integration and a lot of smile on our faces! '

For the next CTs, the team supports the presence of athletes from other states. Eduardo Martins, from Vitória, "hopes that athletes from other states can come to have an even greater union, to improve the experience and techniques of each one. I found it a great opportunity for me as an athlete."

CT POLO BA / SE / ES **OCTOBER 15-18 14 PARTICIPATING ATHLETES**



Polo BA / SE / ES was unable to perform a full CT due to training restrictions in these states. Authorized to use only small boats, they opted for reduced training and virtual meetings for technical analysis and discussion between the coaches and athletes involved. At the hub's headquarters in Salvador, the Regional Leading Technician, Antônio José dos Santos, brought together 14 athletes from the local clubs for training.

Rower Bruno Lopo, from Esporte Clube Vitória (BA), says that he found it "a great experience due to the fact that it brings all the clubs together in a single objective: the evolution of all." Thaise Santos, from São Salvador (BA), has good expectations for the rowers: "It was a great opportunity for everyone, for everyone's evolution. I hope to have good results!"

4. REMO4 PROGRAM

CT POLO RN / PE

OCTOBER 15-18 15 PARTICIPATING ATHLETES



The Polo RN / PE CT took place in Natal, between 15 and 18/10, with 15 athletes from the clubs Potengy (RN) and Sport Club de Natal (RN). There were also two athletes called up from Pernambuco, but unfortunately they were unable to move until Natal. In addition to the Regional Leading Technician, Fernando Madruga, three more technicians participated.

The exchange of knowledge between the participants was one of the points praised by the coach Altair Souza Junior, from Potengy. "It was very interesting to participate in the field. This interaction between coaches is important, we can exchange knowledge and absorb information. We hope that in the next camp, people from Recife can participate with us."

Among athletes, friendship was the highlight. Julia Mello Pereira, from Potengy says that, before, the clubs did not interact very much: "I thought it was good because it ended up influencing humility and trust among the athletes, because we were not united. We evolved during these days. " Ana Beatriz Rocha, from Sport Natal, also highlighted this point: "We had the experience of merging the clubs and testing new boats."

CT NATIONAL

NOVEMBER 01 - 14 50 ATHLETES CALLED

4.4 NATIONAL CT

Two weeks of intense training, activities and integration confirmed the success of Remo4 during the program's first National Training Camp. The CT was held at Ilha do Pavão, in Porto Alegre, headquarters of the Grêmio Náutico União, between the 1st and the 14th of November, with the participation of the Junior, Sub 23, Senior and Pre-Olympic.

In addition to the Junior and Sub 23 athletes summoned after the Remo4 Regional CT was held in October, the Senior team and the athletes in preparation for the Continental Olympic Qualification Regatta for Tokyo participated in this training. In the Junior and Sub 23 team, 28 athletes were summoned (12 rowers and 16 rowers, representing 10 clubs from Bahia, Federal District, Paraná, Rio de Janeiro, Rio Grande do Sul and Santa Catarina.

In the Senior team, 13 athletes were called (5 rowers and 8 rowers) and in the pre-Olympic team 5 men and 4 women. Nine technicians led the activities, along with CBR technical manager Marcello Varriale and head coach Bernhard Stomporowski. Of the total summoned, four athletes were unable to participate due to the positive diagnosis of COVID-19 with a test carried out before the trip.

For Remo4's national leader trainer, Letícia Muziol, CT Nacional demonstrated the athletes' commitment to the program. "Everyone was respectful, determined, warriors, we could see in the eye the joy of being involved in this new phase of Brazilian rowing. Now, it's up to [the athletes] to take everything







On 11/7, the conversation was with Edson Filho about mental preparation in the sponges. On 11/10, athletes from the Junior and Sub 23 categories participated in a workshop on boat regulation. To conclude, the team received the nutritionist Fernanda Donner for a conversation about nutrition and anthropometric assessment, held in all athletes on 11 and 12/11.

what they learned for the clubs and make our sport stronger and more united!"

Before the trip to Porto Alegre, the participants summoned to CT Nacional had to present negative tests for COVID-19. Arriving in the capital of Rio Grande do Sul, athletes and coaches underwent new PCR-type tests, funded by CBR, to confirm the negative diagnosis. Only one athlete had a positive result and was removed from training.

To make the experience more enriching for athletes, CBR organized several complementary activities. On 11/05, coach Thiago Almeida, better known as Capi, gave a lecture. He presented his career in rowing and talked about the influence of sport in his life. On 11/06, it was the turn of the physiotherapist Tarciso Santos to give a lecture on sports physiotherapy.

TRAINING

TRAINING ABOUT ARBITRATION AND COSTAL ROWING

5.1 ARBITRATION CLINIC

Between July and August, the Online Clinic of Arbitration took place, a series of webinars conducted by CBR on arbitration in rowing. The classes were given by the Director of Arbitration and Vice President, Magali Moreira.

The first edition, on 7/1, talked about the Control Commission and received 71 applications. In the second edition, held on 07/08 with 73 subscribers, Magali spoke about Aligner and Match. In the third and last edition, on 07/15, with 96 entries received, Magali received the international referee Jose Tord as a guest to talk about costal rowing. Jose was president of the Peruvian Rowing Federation and led the organization of the World Rowing Costal de 2015, held in Lima.

In the fourth edition, on 07/22, Magali talked to the participants about arrival and departure - rowing. Paragliding continued to be an issue in the edition of 07/29, which was attended by Eliana Muthcnik, a FISA classifier with 15 years of experience in Paralympic sport, including the project to include para-rowing in the Beijing 2008 Paralympic Games. Finally, on 08/05, Magali held a class on the general referee, who is the referee who follows the entire race on the launch.

5.2 BEACH SPRINT TRAINING

Continuing with the development of national projects for the implementation of coastal rowing, a training course on the organization of coastal rowing events was held on 07/20 with Guin Baten, member of the Rowing Council

World Rowing is responsible for the organization of the World Cups in the category. Guin is one of the leading cost rowing experts today.

The training was focused on organizing a Beach Sprint championship. Guin explained about the choice of the site, security planning, necessary equipment, assembly of the space and format of realization. FISA's continental representative in South America, Victoria Aguirregomezcorta, also participated, supporting CBR's initiative in the modality.

Marcello Varriale, Magali Moreira and Saulo Deboni, from CBR, participated in this training, together with Letícia Muziol (continental FISA trainer and tutor for development), Edson Salles (trainer), Frederic Mallrich (trainer) and Ana Kazz, who has experience in organizing these events through working with FISA. In addition to the development of national projects, CBR is studying the creation of a costal rowing committee.

SCIENCE AND SPORT TOGETHER IN HIGH PERFORMANCE

5.3 PARA-ROW PARTNERSHIP AND HERO SPORTS SCIENCE

In early November, a partnership was signed with Hero Sport Science, a sports performance and physical evaluation clinic, to accompany athlete Claudia Santos in training until the Paralympic Qualification Regatta, in Gavirate.

Hero Sport Science is led by the physiologist Heros Ferreira, Ph.D in Sports Science with an extensive track record of acting in Olympic and Paralympic sports, including the achievement of three Olympic medals and one Paralympic as a sports scientist. With the supervision of Fernando Carvalho, CBR coach, the collected data will be used in the prescription and control of the athlete's training during her preparation for the qualifying race.

The partnership was formalized on 11/05 at CBR's headquarters in Florianópolis, with the presence of Heros Ferreira, Fernando Carvalho and the president of CBR, Edson Altino Pereira Junior.

DEFINITION OF SHORT BOATS FOR SOUTH AMERICAN 2021

5.4 INTERNAL QUALIFICATION

The Internal Qualification was held in Rio de Janeiro, between November 27th and 28th, to define the athletes that would compete in the Single Skiff and Two Sem in the South American Junior and Senior Rowing 2021. The qualification counted with the participation of 63 athletes. 20 female boats and 29 male boats.

In Single Skiff, Evelen Cardoso, from Flamengo (RJ) and Marcelo Almeida, from Botafogo (RJ), were selected in the Junior category. At Lightweight, the places were with Vanessa Cozzi and Piedro Tutchtenhagen, both from Flamengo (RJ).

In the Dois Sem Feminino and Masculine boats, the Junior category places were for Shaiane Ucker / Mariana Macedo and Facundo Mezquita / Robson Aguiar, Flamengo doubles (RJ), and in Dois Sem Feminino Júnior there was only one boat registered. In the Lightweight category, Vangelys Reinke and David Faria, from Flamengo (RJ), obtained the best results.

In Dois Sem Feminino there was only one registration, confirming athletes Milena Viana and Maria Clara Lewenkopf, from Flamengo (RJ). In Dois SemMasomens, Alef Fontoura and Fábio Moreira, from Flamengo (RJ), were in first place in both finals of the category.

According to the rules, the athletes confirmed the places by winning the largest number of events in three attempts. However, all winners of the first Finals achieved the same result in the second heat, already defining the vacancy at this stage. In classes with five or more registrants, disputes were initially held in Time Trials.

6. MANAGEMENT AND TRANSPARENCY

COVID-19

MEASURES FOR COPING OF PANDEMIC BY CBR

6.1 COVID-19 PROVIDENCES

After the arrival of the COVID-19 pandemic in Brazil, CBR took several measures and actions to deal with it. This information was formalized through a letter sent to the affiliated federations and to the CBR Athletes Commission on April 3.


At the national level, CBR suspended or canceled the events, training, internal qualifications and competitions provided for in the national calendar of 2020. At the international level, all competitions were canceled until August 2020, as well as the transfer to the year 2021 of the Games from Tokyo.

The CBR Technical Coordination followed and guided the athletes following their training, with appropriate recommendations for isolation and social distance in order to avoid contagion, in order to continue with everyone's activities and fitness.

The CBR team went to remote work, so that there was no interruption in the flow of administrative routines, until it was possible to return to normal activities in the offices. Even with the extension of some deadlines, the rendering of accounts for all projects continued in progress.

On June 1, following the release of sports activities in the states, CBR published in a complete protocol for the safe return to the practice of rowing. The content presents information on when to resume activities, who should and should not practice at this time and the main risk areas. The material complies with World Rowing recommendations.

6.2 GET PROGRAM

CBR closed the 2020 Cycle of the GET Program -Management, Ethics and Transparency, earning 9.99 points in the overall index. This was the second best score among the participating confederations, out of a total of 10 possible points. Launched in 2017, the program is a COB initiative to develop the management of sports entities.

The areas with the greatest evolution in CBR were Strategy, with 167% increase in the grade, and Compliance, with 133% increase. In Strategy, it was assessed how the confederation deals with the management of its projects and its strategic planning. In Compliance, actions related to ethics, policies, integrity, auditing and internal controls are evaluated. With an index above the CBR, there were seven confederations with 10 points, however, the COB does not disclose the results publicly and it is up to each entity to decide to disclose its score.

The program started in 2017 with the structuring of the model by the COB. In 2018, the first visits to the confederations were carried out to diagnose and monitor actions. In 2019, the program was expanded with actions focused on transparency, ombudsman and strategic planning. In 2020, GET offered personalized support to confederations, indicators performance reports and webinars for training the professionals involved. To define the index, confederations are evaluated in five areas of knowledge: Governance, Strategy, Transparency, Processes / Support and Compliance. In total, 345 questions are analyzed according to the size of each entity. The GET Program score is one of the 12 items evaluated by the COB in the annual distribution of resources to sports.

6.3 COMMITTEE OF ATHLETES

On the 27th of June, the president of CBR, Edson Altino Pereira Junior, held a live on YouTube of the confederation to clarify doubts about the Athletes Commission. The chat was open for questions throughout the broadcast. Edson explained about the inclusion of the Commission in the bylaws, its performance and how to participate.

The national Athletes Commission was formalized in the CBR bylaws in 2013, according to the new provisions of the Pelé Law. The election of representatives is made by the athletes themselves and the applications are made after the announcement of the notice. Edson stressed that CBR is open to talking with athletes and invited them to participate in state commissions as well.

6.4 BRAZILIAN CLUB COMMITTEE

On Thursday, 08/13, the president of CBR, Edson Altino Pereira Junior, participated in a live with Fernando Cruz, vice president of training of athletes of CBC, to talk about the partnership between the two entities. The live was attended by the rower Willian Giaretton and was mediated by sports journalist Fernando Gavini, from the portal Olimpíada Todo Dia.

President Edson praised the partnership with CBC, which allows improving the development of new athletes. The partnership took the rowing championships to a new level, as it allowed CBR to focus on the organization, while CBC takes care of supporting clubs. This increased the number of participants and the technical quality of the events. Edson also spoke about the Resumption of Activities Protocol and virtual events.

7. MARKETING AND COMMUNICATION

COMMUNITY

RELATIONSHIP BETWEEN CBR AND THE ROWING COMMUNITY

7.1 TRAINING AT HOME

With the suspension of the championships and the closing of clubs and lanes during the quarantine of COVID-19, the rowers had to adapt to a new training routine at home. To assist athletes during this period, the medical area of the Olympic Committee prepared a document with tips and recommendations on food, rest and mental health, also released by CBR on its website and social networks.

Since the beginning of March, the athletes of the Brazilian Rowing Team have been preparing to compete in the South American Championship, which would take place in April and has been postponed. Even without the new date until then, our rowers kept their training routine at home. The public followed the athletes' training through social networks, with the posting of videos and photos by CBR.

7.2 Rowing project for everyone

To assist athletes with financial needs, rower Thais Capovilla and rower Alef Fontoura created the Remo por Todos project. Through the sale of products, funds are raised to benefit athletes with less conditions, but who have a good performance and the ability to achieve a successful future in rowing. CBR supported the project through disclosure on the website and social networks.

The project's manifesto explains: "Sport has the capacity to transform lives, as well as thoughts. And it was with this transformation in mind that Remo por Todos emerged. This is a project that goes far beyond the daily strokes, it aims to raise funds for athletes who they have financial difficulties for daily expenses: food, supplements, transportation vouchers, consultation with a nutritionist ... but they also have a bright future within the sport and need our help. "

7.3 ROWING FOR GIRLS

Rowing manual for girls Develop Your Performance on Rowing, launched in March 2019 by WSNet (Women's Sport Network) with support from CBR and World Rowing, was made available in physical version in 2020. CBR obtained the license to print and distribute the material in Brazil and sent it free to clubs.

Suitable for junior rowers, the manual has 50 pages with information to make athletes more confident. In addition to developing specific rowing skills through exercise, topics on body image, nutrition, menstruation, anxiety and injury prevention are presented. Material can also

there are special chapters to guide coaches, coaches, fathers and mothers of young athletes.

The English version, with official support from FISA, was launched during the 2018 Coaches Conference. CBR helped WSNet translate the content into Portuguese and disseminate the manual in Brazil, initially available only in digital format. WSNet (acronym in English for Women's Sports Network) is a non-profit cooperative formed by independent volunteers, who

already has more than 100 thousand participants in its activities around the world.

7.4 PERINEAL HEALTH

In the second week of December, Remo Brasil Talks held a lecture and a round table on the theme Perineal Health - Pelvic Floor Health for Rowing Athletes. The lecture took place on 12/15, led by the physiotherapist Joana Santos, a specialist in pelvic physiotherapy. Joana is a physiotherapist with a postgraduate degree in Pelvic Physiotherapy and has worked as a teacher in the area since 2013. She also takes care of Instagram Saúde Perineal, where she discusses the subject with 23 thousand followers.

On Thursday, 12/17, Joana returned to discuss the matter at a round table with five more physiotherapists. The conversation was mediated by the technical manager of CBR, Marcello Varriale, and was attended by professionals Bruno Melo, Cezar Rodrigues, Flaviano Moreira, Rafael Jacob and Tarciso dos Santos.

The activities were organized in partnership with the technical commission of the Clube Náutico Francisco Martinelli, from Santa Catarina, which suggested the theme and introduced the speaker. 60 registrations were received from athletes, coaches and those interested in the subject.

DISCLOSURE

EVENTS COVERAGE ON THE SITE AND SOCIAL NETWORKS

7.5 INTERNET RESULTS

Due to the cancellations of the national and international races, the 2020 Season had a drop in audience on the internet. The expectation of an increase due to the Tokyo Games was not fulfilled by the change in the date of the event. On the CBR website, there were 32,387 visitors in 2020, a drop of 22% compared to the previous year. The number of visits remained the same as in 2017 and 2018, showing that the actions carried out maintained the annual average of visits, even with the events canceled.

Facebook also returned to the same level of 2018 with 164,060 people reached. A drop in audience on this network had already been noticed due to changes in the platform and a decrease in the number of active users. The average view per post demonstrates this, with a sharp drop of 60%.

The result, however, is positive for a year with only three championships held. On Instagram, we gained 818 new followers in one year, an excellent result for the pandemic period. The realization of online events maintained a good audience rate, close to the result of 2018 with 118,549 people reached. Due to the decrease in the number of posts, the average viewership increased by 100%.

Twitter surprised with a 33% increase in audience, closing the year with 108,173 views. On YouTube, views decreased because we only have one championship broadcast. The result, however, was three times greater than in 2018, registering

a growing increase in public interest in CBR broadcasts. In 2020, we also made available Remo4 training videos on our channel, which contributed to the good result of visits on YouTube.

The Remo Brasil Indoor Rowing Challenge can now be considered a successful case of CBR. The two editions, held in 2020, had 98% of participants' satisfaction. The audience was close to Barcos Curtos, demonstrating that there is great public interest in this type of event. Between the first and the second edition, the increase was 36% in the audience, with 106,429 registered views.

7.6 PLAY TRUE DAY ACTION

On 09/04, the International Fair Game Day, Play True Day, was celebrated by the World Anti-Doping Agency (WADA) to encourage the fight against doping in sport. The objective of this date is to raise awareness among athletes, coaches and the public about the importance of fighting doping in sport.

To assist rowers with the main doubts about doping, CBR summoned medalists Vangelys Reinke, Willian Giaretton, Milena Viana, Rene Pereira and trainer Letícia Muziol to participate in an action on social networks. Images of the campaign and anti-doping tips for athletes were shared.

AUDITOR'S REPORT INDEPENDENT ON THE ACCOUNTING STATEMENTS: DISCLAIMER

We have examined the financial statements of the Brazilian Rowing Confederation, which comprise the balance sheet as of December 31, 2020 and the respective statements of the surplus (deficit), changes in equity and cash flows for the year ended on this date, as well as the summary of the main accounting practices and other explanatory notes. In our opinion, except for the effects of the matters described in the following section entitled "basis for gualified opinion", the aforementioned financial statements adequately present, in all material respects, the equity and financial position of the Brazilian Rowing Confederation on December 31 2020, the performance of its operations and its cash flows for the year ended on that date, in accordance with accounting practices adopted in Brazil.

BASE OF OPINION WITH DISCLAIMER

As mentioned in Explanatory Note No. 3.4, the entity depreciates property, plant and equipment in accordance with the depreciation tax rates determined by the Federal Revenue Service -SRF. Technical pronouncement CPC 27 - "Property, plant and equipment" requires that depreciation be calculated based on rates that take into account the expected useful life of the assets. In addition, the entity does not have individual control over the assets recorded in property, plant and equipment. There is also a donation of boats received after the Pan American Championship whose boats are in the possession and responsibility of the Confederation, but are not recognized in the entity's balance sheet. Consequently, we were unable to obtain appropriate audit evidence.

and sufficient in relation to the balances of property, plant and equipment, as well as depreciation on December 31, 2020, with a net balance of property, plant and equipment of R \$ 3,371,511.95. Our audit was conducted in accordance with Brazilian and international auditing standards.

We are independent in relation to the Confederation in accordance with the relevant ethical principles set out in the Professional code of ethics and in the Professional Standards issued by the Federal Accounting Council - CFC and we comply with the other ethical responsibilities in accordance with these standards. We believe that the audit evidence obtained it is sufficient and appropriate to support our opinion.

OTHER INFORMATION ACCOMPANYING THE FINANCIAL STATEMENTS AND THE AUDITOR'S REPORT

The Company's Management is responsible for this other information, which comprises the Management Report. Our opinion on the financial statements does not cover the Management Report and we do not express any form of audit conclusion on this report. In connection with the audit of the financial statements, our responsibility is to read the Management Report and, in doing so, consider whether that report is materially inconsistent with the financial statements or with our knowledge obtained from the audit or, otherwise, it appears to be significantly distorted. If, based on the work performed, we conclude that there is a material misstatement in the Management Report, we are required to report this fact. We have nothing to report in this regard.

NOTE 6.2 - Extraordinary COB Revenue: Amount referred to in the First Term of Advance to the Donation Agreement, including charges between the Brazilian Olympic Committee and the Brazilian Confederation of Rowing for the Acquisition of Goods, according to letter -154 / CBR-P. The amount comes from COB's own resources, it was transferred through an extra budget project for the acquisition of 05 (five) costal skiff boats and a truck-type car for the transportation of boats and the performance of CBR services.

NOTE 6.3 - COB and CPB returns: These are Glossed Resources by the Brazilian Olympic Committee, and paid for with their own resources, the administration is working to guide everyone who uses expenses, the responsibility of acquiring and presenting legible documents in the rendering of accounts, so as to remedy the fact on the part of the inspection agency.
